3. SELFONE / CELL PHONES



Ons vra weereens dat leerders hulle selfone baie mooi oppas. Daar sal seker ongelukkig altyd 'n paar karakters wees wat fokus op diefstal van selfone en die skool doen moeite om hulle vas te trek. Ons skroom nie om hierdie leerders summier uit die skool te sit, indien hulle gevang word en skuldig bevind word, nie. Daar is ongelukkig nie om elke hoek en draai kameras nie, alhoewel ons besig is om kameras op strategiese plekke te installeer. Ons kan egter steeds nie verantwoordelikheid vir die diefstal van selfone aanvaar nie. Leerders moet bedag wees daarop dat hulle hul selfone baie veilig moet hou en lief, indien moontlik, nie skool toe bring nie.

CELL PHONES

We ask once again that learners look after their mobile phones. Unfortunately, there will always be a few characters who focus on stealing mobile phones and the school tries to catch them. We do not hesitate to summarily expel these learners from school if they are caught and found guilty. Unfortunately, there are not cameras around every corner, although we are installing cameras in strategic locations. However, we still cannot accept responsibility for the theft of mobile phones. Learners must be aware that they must keep their mobile phones very safe and preferably, if possible, not bring them to school.



4. ROOK EN “VAPE” / SMOKING AND VAPING

Op bladsy 73 van die prospectus word die skoolreëls rakende rook en vape duidelik gestipuleer. Nie net is die gebruik van hierdie middele verbode op die skoolterrein nie, maar ook teen die wet vir enige persoon onder die ouderdom van 18 jaar. Dit bly steeds ouers se verantwoordelikheid om te verseker dat hulle kinders hulle nie skuldig maak aan hierdie tipe gedrag nie. Ons vra dat ouers daadwerklik ‘n gesprek met hul kinders het oor die gevare van rook en vape. Die reël geld steeds, dat indien ‘n leerder gevang word waar hy/sy vape of rook, sal die leerder vir 3 dae geskors word en alles sal gekonfiskeer en vernietig word.

On page 73 of the prospectus, the school rules regarding smoking and vaping are clearly stipulated. Not only is the use of these substances prohibited on school grounds, but also against the law for any person under the age of 18. It remains the parents' responsibility to ensure that their children are not guilty of this type of behaviour. We ask that parents have a serious conversation with their children about the dangers of smoking and vaping. The rule still applies, that if a learner is caught vaping or smoking, he/she will be suspended for 3 days, and everything will be confiscated and destroyed.



5. MASELS-INENTING / MEASLES VACCINATION



Op **27 en 28 Februarie** sal verpleegsters ons skool besoek om vir die **Gr. 8 en 9-leerders** hul masels inenting te gee. **SLEGS** die leerders wat hulle toestemmingsbriewe terug besorg het aan sy/haar voogonderwyser sal die inenting ontvang.

*On 27 and 28 February nurses will visit our school to give the Gr. 8 and 9 learners their measles vaccine. **ONLY** the learners who returned their permission slips to his/her register teacher will receive the vaccine.*

6. AFWESIGHEDE / ABSENTEEISM

Skoolbywoning word beskryf in die "Learner Attendance Policy" soos uiteengesit in die National Education Policy Act van 1996 en die Government Gazette No. 33150 van Mei 2010.

Hiervolgens geld die volgende:

- Teenwoordigheidsregisters word daaglik geneem, dit word gedurende voogperiode hanteer. Indien die leerder nie fisies in die klas is nie, word hy/sy afwesig gemerk.
- Afwesighede word deur die data-beampte ingelees en die ouers ontvang 'n SMS as kennisgewing. Vakpersoneel hou ook elke periode teenwoordigheidskontrole. Indien 'n leerder die spesifieke periode afwesig is, word dit as sodanis aangeteken. 'n Leerder wat egter wel by die skool is, en die spesifieke periode mis, sonder enige kennis/reëling met die vakonderwyser/es, word as "glip/bank" aangeteken.
- Onder geen omstandighede mag leerders self hul ouers gedurende skoolure kontak nie. Indien daar 'n noodgeval is sal die kantoor ouers kontak.
- Indien 'n leerder/s moet tuisbly as gevolg van 'n siekte, ens. moet die skool in kennis gestel word deur middel van 'n e-pos aan admin@gerries.co.za te stuur en sodoende die rede vir afwesigheid te verskaf.
- Indien geen e-pos of kennis aan die skool gestuur word nie (op die dag van afwesigheid of tot drie dae daarna), sal die afwesigheid as stokkiesdraai gesien word en volgens die dissiplinêre stelsel hanteer word.
- Indien die leerder enige vorm van formele assessering mis as gevolg van afwesigheid, moet 'n mediese sertifikaat ingehandig word.

School attendance is described in the "Learner Attendance Policy" as set out in the National Education Policy Act of 1996 and the Government Gazette No. 33150 of May 2010

Accordingly, the following applies:

- *Attendance registers are taken daily, this is handled during guardianship period. If the learner is not physically in class, he/she is marked absent.*
- *Absences are read in by the data officer and the parents receive an SMS as notification. Subject staff also conduct attendance checks every period. If a learner is absent for the specific period, it is recorded as such. A learner who is, however, at school, and misses the specific period, without any knowledge/arrangement with the subject teacher/s, is recorded as "slip/bank".*
- *Under no circumstances may learners themselves contact their parents during school hours. If there is an emergency, the office will contact parents.*
- *If a learner/s must stay at home due to an illness, etc. the school must be notified by sending an email to admin@gerries.co.za and thus providing the reason for absence.*
- *If no e-mail or notice is sent to the school (on the day of absence or up to three days after), the absence will be seen as truancy and dealt with according to the disciplinary system.*
- *If the learner misses any form of formal assessment due to absence, a medical certificate must be submitted.*

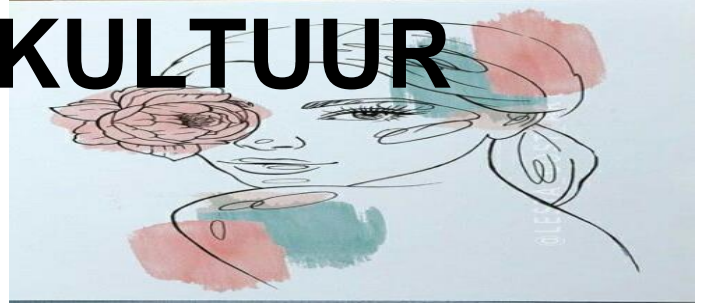

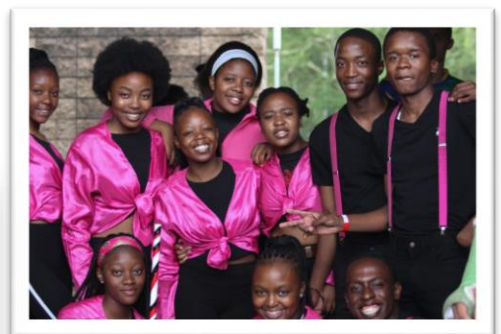
